**2021 BOAT REGISTRATION & RULES AGREEMENT**  
**SEVEN LAKES LANDOWNERS ASSOCIATION (THE “ASSOCIATION”)**

Permit Valid from May 1, 2021 through April 30, 2022

**Requirements for Registering a Boat**

- Individual must be a Member of SLLA and current on all assessments due to SLLA on **all** lots owned.
- **Proof of CURRENT LIABILITY INSURANCE for all powerboats and sailboats.**
- Insurance must be in the name of the member and include boat description(s).
- **Owner must Pass the SLLA Boater Quiz with 100%**
- Copy of proof of ownership (Title/Bill of Sale) on all new vessels being registered showing MAKE, MODEL #, SERIAL #, VESSEL #.
- **\$15 payment** (cash or check)
- All boats must be registered, or listed with the front gate, prior to entering the community; regardless of whether they are allowed or intended to be used on the lake.

**SLLA Rule & Regulation 8.4.2.2 Powerboat owners are required to register their powerboat(s) annually. Only Members in good standing and AFTER successfully passing the SLLA Boater Quiz with 100% will be issued new stickers. Once a powerboat is properly registered, a pair of stickers will be issued by the Landowners’ office.**

**8.4.2.1 states** “Every **POWERBOAT** within Seven Lakes is required to be registered with the Landowners’ Association. No unregistered powerboats will be allowed through SLLA gates. A powerboat is defined as any boat with an internal combustion engine and/or electric motor...”

**8.4.3.4** The maximum powerboat length on Lake Sequoia is 23’0” and the maximum powerboat length on Lake Echo is 18’0”. The maximum pontoon boat length on Lake Echo is 20’0”. Boat length is defined by the boat manufacturer, as listed on the boat registration or insurance certificate. There is no restriction on the length of sailboats, even those with a gas outboard.

**Please Note:**

**\*If registration is not completed by May 15, 2021 a \$30 registration fee will be charged.**

**\*After May 1, 2021, the 2020 decals will no longer be recognized and boats not displaying the current decal and hull numbers will be subject to fines in accordance with the SEVEN LAKES LANDOWNERS ASSOCIATION.**

**Failure to provide accurate information will result in cancellation of the registration and forfeiture of the right to use the vessel on the lakes. Should an administrative error occur during the registration process the Association reserves the right to correct the error.**

**This release and hold harmless form must be signed in order to receive a Boat Decal.**

I have read and understand the SLLA Rules and Regulations. I understand compliance with all SLLA boating rules and regulations is mandatory. I acknowledge operation of said powerboat on any SLLA Lake is the sole responsibility of the boat owner, regardless of who is operating the boat at the time of the violation and that any violation of SLLA Boating Rules and Regulations may result in boat owners being cited and taken before the Judicial Committee, who has the right to fine the boat owner and / or suspend boating privileges.

Permit Valid from May 1, 2021 through April 30, 2022

Boat trailers left at the parking area at Sequoia need a current registration sticker for parking there.

The fee is \$50.00, renewable the 1<sup>st</sup> day of the fiscal year (May 1<sup>st</sup>)

**\*IF YOU ARE LEASING A BOAT SLIP, THE \$50 FEE IS INCLUDED IN YOUR \$450 BOAT SLIP LEASE FEE IF STORING AT THE YARD DEBRIS SITE.**

Sticker must be affixed to the trailer and be visible to security.

By registering this boat trailer for \$50 I may park at the Sequoia Boat yard during the period from May 1, 2021 – April 30, 2022 as long as I am a property owner, have a current lease filed with the Landowners Office and ONLY if I have been assigned a spot at the Sequoia Boat yard. I agree to remove my boat trailer from the property if I am no longer a resident, even if the sticker has not expired.

If not storing the boat trailer at the Sequoia parking area, the trailer must be stored in compliance with the rules and regulations 5.1.1.3 to 5.1.1.3.1.
